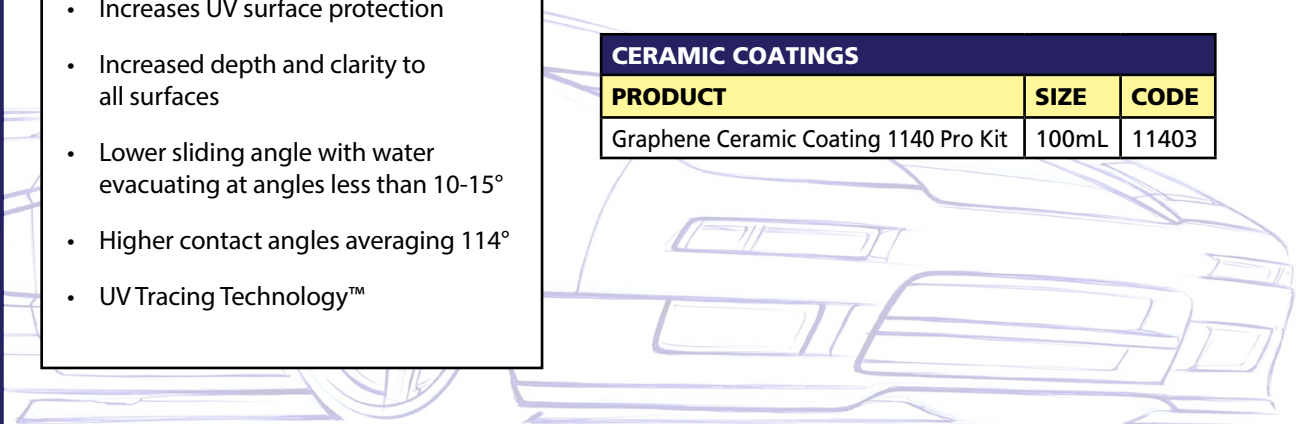

## GRAPHENE CERAMIC COATING 1140 PRO KIT

### PRODUCT DESCRIPTION

Formulated to incorporate graphene oxide, American Icon Graphene Ceramic Coating 1140 Pro Kit creates a more durable glass-like coating on the vehicle surface for additional protection and improved appearance.

With twice the activity of standard ceramic formulations, American Icon Graphene Ceramic Coating 1140 Pro can be used for gelcoat in Marine and RV applications, as well as on automotive clear coats.

**PROPER SURFACE PREPARATION IS ESSENTIAL TO ACHIEVE A HIGH QUALITY FINISH. READ THE SDS SHEET AND WEAR PROPER PROTECTION, WHICH MAY INCLUDE GLOVES, EYE PROTECTION, AND/OR OTHER PROTECTIVE DEVICES.**

### SURFACE PREPARATION / DIRECTIONS

Thoroughly clean to remove old waxes, sealers, tar, iron, and other contaminants. Embedded contaminants should be removed with a clay bar/glove and non-waxed lubricant. Remove scratches with a non-waxed/non-sealant compound and polish to remove defects. Wipe all surfaces with American Icon R-S200 Surface Prep cleaner or an IPA prep solution for ceramic coatings.

Shake well before and during use. Saturate a suede applicator or similar with numerous drops of material from the dripper bottle. Apply the coating to a 3x3 ft<sup>2</sup> area of the vehicle using a cross-hatch pattern with slight overlap to level the product. Allow the coating to cure for 1-2 minutes and gently remove excess product using a clean suede cloth or low nap microfiber towel. You can check for missed areas with a UV light. Do NOT allow coating to come in contact with water for 24-48 hours while curing - if it does, remove water promptly. Apply additional coats with at least one hour between applications or immediately following a single pass around the vehicle. Do NOT apply in direct sunlight or to a hot surface. Cure time is dependent on environmental conditions. Test product on a small inconspicuous area first to gauge cure time. Don't wash vehicle for 7 days after application.
