#### SURFACE PREPARATION

1. Allow the final coat of basecoat to dry to touch prior to applying C-831 UNIVERSAL CLEAR 2.1

2. Use a tack cloth to remove any surface contaminates that may have settled on the basecoat.

3. Apply C-831 UNIVERSAL CLEAR 2.1

#### PREVIOUSLY FINISHED SURFACES:

1. Sand surface with P600 wet or dry, and then clean with R-S200 SURFACE CLEANER.

### REMEMBER TO STIR THIS PRODUCT BEFORE USE.

#### **MIXING RATIO 4:1**

4 parts C-831 UNIVERSAL CLEAR 2.1 to 1 part A-S361, A-M371 or A-F381 ACTIVATOR.

**NOTE**: Substrate temperature for application minimum 50°F and maximum 100 °F

#### **APPLICATION INFORMATION**

Apply 2-3 full wet coats with 50% overlap.

Pot Life 3-5 hours @ 70° F/21° C depending on temperature, humidity and activator selection.

#### CLEAN UP INSTRUCTIONS
